1. The convertible preferred stock is convertible at any time at the holder's election, without payment of additional consideration, and has no expiration date but is expected to convert automatically upon the closing of the Issuer's initial public offering.

Series F Convertible Preferred Stock reported herein represent, on an as-converted basis, (i) 10,260,600 shares held by Cormorant Private Healthcare Fund I, LP ("Fund I"), (ii) 3,242,400 shares held by Comorant Global Healthcare Master Fund, LP (the "Master Fund") and (iii) 497,000 shares held by a managed account (the "Account").
3. Comorant Asset Management, LP ("Comorant") serves as the investment manager of Fund I, the Master Fund and the Account. Bihua Chen serves as manager of the general partner of Comorant. Each of the Reporting Persons disclaims beneficial ownership of the shares reported herein except to the extent of its or her pecuniary interest therein, and the filing of this Form 3 shall not be construed as an admission that any of the Reporting Persons is the beneficial owner of any such shares for purposes of Section 16(a) of the Securities Exchange Act of 1934 or for any other purpose.
